Abstract Guideline

Length of Abstract: 300 words

- **Format:** Typed, Times New Roman Font, size 12 pt and 1,5 spacing
- **Margins:** 25mm on sides. 20mm top and bottom.
- **Title:** Centred and in capital letters. The names, affiliations and country of author and co-authors must appear under the title.
- The text must begin at the margin (do not indent).

Paper Guideline

The Conference Proceedings will be prepared from papers received from the authors. Check your paper carefully as the committee will not correct mistakes.

- **Length of Paper:** papers must not exceed 10 pages, including illustrations, tables and references.
- **Format:** Times New Roman Font, size 12 pt and 1,5 spacing.
- **Margins:** 25mm on sides. 20mm top and bottom.
- **Title:** Centred and in capital letters. The names, affiliations and country of author and co-authors must appear under the title.
- **Illustrations:** There must be a caption below figures and photos. Please note these figures and photos will be printed in black and white in the proceedings booklet.
- The text must begin at the margin (do not indent).
- Each headed or sub-headed section should be numbered using a decimal system.

Professor Gary Jones

Gary Jones graduated in 1957 at Cambridge. Some years later he was awarded his PhD at the University of Natal for research on the development of the piezocone for the determination of the geotechnical properties of the recent alluvial deposits along the eastern coast of South Africa.

He began his career in Zimbabwe and followed this with spells in the UK and Uganda before settling in South Africa where he worked for consultants, the Natal Roads Department and the CSIR before joining SRK Consulting.

Having retired from SRK in 1998 he became a corporate consultant for them and also an extraordinary professor at the University of Pretoria. Gary is the author of fifty papers and publications on a variety of geotechnical subjects and has received the Jennings Award, the Geotechnical Gold Medal and is an Honorary Fellow of SAICE.
