



CHAMBER OF MINES CERTIFICATES

The following details relate to the examination for the abovementioned Certificates scheduled to be held during May and October of every year:

QUALIFICATIONS OF ENTRANTS:

SURVEY AND VALUATION CERTIFICATES

- 1) Elementary Sampling Certificate: A candidate shall have passed the Basic Mine Sampling Certificate.
- 2) Elementary Survey Certificate: A candidate shall have passed the Basic Mine Survey Certificate.
- 3) Advanced Mine Valuation Certificate: A candidate shall have passed the Elementary Mine Sampling Certificate.
- 4) Advanced Mine Survey Certificate: A candidate shall have passed the Elementary Mine Survey Certificate.
- 5) Mine Survey Draughting Certificate: There is no period of qualifying service.

MINE ENVIRONMENTAL CONTROL CERTIFICATES

- 1) Intermediate Certificate in Mine Environmental Control/Occupational Hygiene are as follows:
 - a) A candidate shall have had at least six months service in environmental control departments of mines, members of the Chamber, or such other experience in mine environmental control work as may be approved by the Examination Committee at its discretion.
 - b) A graduate of a recognised university or school of mines in mining, metallurgical and other engineering subjects, or in science with either physics, chemistry, mathematics or geology as a major subject, will be admitted to the Intermediate Examination after not less than three months experience in an environmental control department of a mine, member of the Chamber, or such other experience in mine environmental control as may be approved by the Examination Committee at its discretion.
- 2) Certificate in Mine Environmental Control/Occupational Hygiene are as follows:
 - a) Candidates shall have passed the Intermediate (formerly Elementary) examination; and
 - b) Candidates shall have had at least twelve months experience in environmental control work or such other experience as may be approved by the Examination Committee at its discretion.
 - c) A graduate of a recognised university or school of mines in mining, metallurgical and other engineering subjects, or in science with either physics, chemistry, mathematics or geology as a major subject, will be admitted to the examination after not less than six months experience in an environmental control department of a mine, member of the Chamber, or such other experience in mine environmental control as may be approved by the Examination Committee at its discretion.

ROCK ENGINEERING CERTIFICATES

1. Strata Control Certificate: Candidates from mines which are not members of the Chamber may be accepted for the examination at the discretion of the Examination Committee provided they can comply with the specified requirements.

2. Rock Mechanic's Certificate:
 - a) A candidate shall already be in possession of the Chamber of Mines Strata Control Certificate (formerly Elementary Rock Mechanics Certificate); and
 - b) Candidates shall have had at least six months experience in Rock Mechanics departments of mines or such other experience in rock mechanics as may be approved by the examination Committee at its discretion.
 - c) Massive mining and Open Pit practitioners need to submit a CV if not in possession of a strata control certificate.

ENTRANCE FEE:

Candidates will be required to pay an entrance fee of **R1 000, 00 per paper**.
